The new complaint of IRIB against the founder of Aparat and Filimo

Mohammad Javad Shakouri Moghaddam, the founder of Sabaidea Holding, which owns Aparat and Filimo brands, announced in a post on X social network that IRIB has sued him for broadcasting a series of programs on Filimo and requested legal action against him.

In this post, which has been published along with a picture of the complaint verdict of IRIB's deputy and the head of Satra, a complaint request has been sent to the prosecutor of Qom in cyber space affairs. The complaint also mentions the publication of photos and images and materials that violate public modesty.

Mohammad Javad Shakouri Moghaddam wrote in this regard: "Now I have received the notification of IRIB's complaint. The deputy of that organization has requested the judiciary to prosecute me for broadcasting football matches and broadcasting Joker, Actor, Set me Free, The Fall and three other series along with the removal of these series from Filimo. In this post, he emphasized that their main party is IRIB, not the monitoring arm of this organization, i.e. Satra.
